IV. HEARING

Hollis Hills Farm, 340 Marshall Rd. for Alteration of Premises – approval of outdoor permanent serving area. New premises proposed description as follows: Four story building totaling 11,800 sq.ft. 1st floor 3,600 sq.ft., one main room with two restrooms. 1st floor has 3 entrances/exits. 1st floor has two entrances to outdoor wrap around deck. Deck is 1,500 sq.ft. 2nd floor is 2,200 sq.ft. One room with seating remainder offices. 3rd floor 3,600 sq.ft. of storage (upstairs of barn) basement of 3,600 sq.ft. of commercial kitchen storage. Also permitting 3.78 acres of lawn/orchard for functions, and ¾ acre animal viewing area. Dimensions of the outdoor extended service area (alcohol and food service) are 50'8" x 11'4". An enlarged service window for access to the kitchen is 3' x 3'10" with a 21" sill height.

TO: ALCOHOLIC BEVERAGE LICENSEES RE: 2019 LICENSE RENEWAL PROCESS

Your current license to sell alcohol expires on December 31, 2018. Please read completely and follow all directions for renewal. Failure to sign the renewal will result in loss of license. There will be no further reminders.

- 1. Renewal Affidavits for 2018 licenses must be signed in person in the City Clerk's Office, 166
 Boulder Drive <u>between November 7 and November 30, 2018.</u> Failure to sign during the month of
 November will result in loss of license and require that you go through an application process for
 a new license during which time your establishment would be closed for business.
- 2. The office will be closed on Monday November 12th for Veterans Day and Thursday and Friday November 22nd and 23rd for the Thanksgiving holiday. Please plan accordingly.
- 3. One of the following individuals are authorized to sign the renewal affidavit in person, provided that he/she has been disclosed and approved in writing by both the License Commission and the ABCC: A shareholder, director or officer of a corporation; a member or manager of an LLC; the manager of record; an appointed trustee in bankruptcy; an appointed administrator/executor of the estate of a deceased licensee; a pledge-holder who has filed the required financing statement and foreclosed on the pledge.
- ** For licenses in the process of transfer the license holder as of November 30 must sign and file the renewal.
- ** If the license renewal affidavit is not signed by November 30th it will be assumed that you wish to give up your license to sell/serve alcoholic beverages.
- ** If you do not come in to sign your license renewal affidavit by November 30th and later decide that you want to continue selling alcohol in 2019, you will not be able to renew your existing license. Instead, you will be required to apply for a NEW license, if there are any available. Applications for a new license must be reviewed and approved, after public hearing, by the local License Commission and then go to the ABCC in Boston for final approval. The process takes at least two months. During that time, you will not have a license to sell alcohol.

For pouring, on premise licensees (restaurants, clubs, bars etc), in addition to signing the renewal affidavit by November 30 it is your responsibility to obtain and deliver the three documents listed on the next page to the City Clerk's office no later than 4:30PM, Wednesday, December 12, 2018.

1. As required by Chapter 304 of the Acts of 2004, An Act Relative to Fire Safety In the Commonwealth, all holders of a s. 12 license (pouring on-premises restaurant, hotel, tavern, club, war veterans club or general on premise) are required to submit a copy of a valid certificate of inspection issued and signed by the City of Fitchburg building inspector and signed by the head of the Fire Department prior to renewal of the license. Please be reminded that you must schedule an appointment with the Building Department and/or the Fire Department before your certificate of inspection will be issued therefore, please plan accordingly.

2. For all on-premises M.G.L. c.138 sec 12 applicants and licensees: <u>proof of insurance coverage</u> under a liquor legal liability insurance policy for bodily injury or death for a minimum amount of \$250,000 on account of injury to or death of 1 person, and \$500,000 on account of any 1 accident resulting in injury

or death of more than 1 person as a condition to renew a license.

3. Pouring, on-premises licensees must complete and sign an application to renew existing permits for the year 2019. (Form available in this office).

All applicants are strongly advised to contact the Building Department and the Fire Department immediately to schedule an appointment for inspection and to discuss requirements for inspection signoff. Be advised that State requirements for Crowd Control Manager may apply to your establishment depending on your occupancy number. The Fire Department will be unable to sign off on your Certificate of Inspection unless you meet the applicable Crowd Control Manager requirements.

Only if you sign your renewal affidavit in the City Clerk's office by November 30 AND submit all of the required documentation as listed above by December 12, will your license renewal be placed on the License Commission agenda for review and approval.

ENTERTAIMENT PERMITS

Please note that your Entertainment Permits also expire on December 31, 2018. You must submit an application for Entertainment, along with the required fee, no later than December 12th in order to have it appear on the License Commission agenda for approval of continued or new Entertainment in January 2019. Applications are included in this mailing.

After your license is approved for renewal by the License Commission in December you will receive an invoice by mail for the 2019 license fee.

You must bring your invoice to the Treasurer's Office at 166 Boulder Drive to pay for your 2019 license on or before Friday, December 28.

Only cash, certified check or money order will be accepted by the Treasurer as payment.

Obtain a "PAID" receipt from the Treasurer and bring it to the City Clerk's office to pick up your actual license. You must have your 2019 license posted on the wall of your establishment in order to sell or serve alcohol after midnight on December 31.

In addition to the "PAID" receipt, the following documents/information must be submitted to the Office of the City Clerk prior to the release of your approved 2019 license:

- 1. A copy of your current Workers Compensation policy declaration page showing the policy number and expiration date, or, a Workers Compensation Insurance affidavit (form available in this office) explaining why you do not carry Workers Compensation insurance.
- 2. Proof that the Manager of Record has successfully completed a TIPS (or comparable) alcohol server course.
- 3. A list of current employees and a copy of their TIPS certification card.
- 4. Signed statement that all state tax returns have been filed and state taxes paid. You must provide your taxpayer ID number on the form provided by this office.
- 5. Certificate of tax compliance from the City of Fitchburg Treasurer's office for the licensed premise.
- 6. A current and active email address where you will receive local License Commission and Massachusetts ABCC information.
