
Patrick Hare, Chief of Staff to the Mayor presented the updated 2021 Ward and Precinct map. The new maps were drawn by the state and reviewed by the Reprecincting Team. The changes will go into effect December 31, 2021.

City Solicitor Vincent Pusateri commented on the map and how to see how the State made its determination for the changes.

Patrick Hare, Chief of Staff to the Mayor, and Tom Skwierawski, Executive Director of Planning and Community Development, answered questions from the Councilors.

Ordinance passed to a first and second reading and ordered advertised by roll call vote of 9 in favor and 0 opposed. 9 members present. Board consists of 11 members.
