

Patrick Hare, Chief of Staff to the Mayor presented the final amended 2021 Ward and Precinct map, physical boundary descriptions, and census track and block numbers. He explained there were a handful of boundary markers that needed to be correctly identified in the legal descriptions. In addition, there was a small error on the map the state provided to us to one of the ward lines. This correction did not violate any of our population parameters.

Motion and second to amend the Ordinance was passed by unanimous consent 9/0.

Ordinance passed to a third and final reading and adopted to be enrolled and ordained by unanimous roll call vote of 9 in favor and 0 opposed. 9 members present. Board consists of 11 members.
